NOTICE OF SIXTH ONLINE PUBLIC AUCTION

Eric Terry (“Mr. Terry”), the chapter 11 trustee (the “Trustee”) for the bankruptcy estates (the “Estates”) of Chris Pettit & Associates (“CP&A”) and Christopher John Pettit (“Pettit,” and together with CP&A, the “Debtors”) hereby gives this notice of his intention to sell via online public auction (the “Notice”) the personal property of the Debtors (the “Personal Property”) identified in **Exhibit 1** to this Notice pursuant to the procedures (the “Auction Sales Procedures”) authorized by the *Order Granting Chapter 11 Trustee’s Motion to Approve Procedures for Sale of Personal Property, Free of Liens, Claims and Encumbrances, Via Public Auction or Private Sale and to Authorize Payments to Auctioneer from Sales Proceeds* (ECF No. 569).
